Section I Name

The name of this Council is General Currie Elementary Parent Advisory Council.

The Council will operate as a non-profit organization with no personal financial benefit accruing to members.

The business of the Council will be unbiased in respect of race, religion, gender, politics, sexual orientation, and physical or mental ability.

Section II Purposes

The purposes of the Council will be:

1. To promote the education and welfare of students in the school
2. To encourage parent involvement in the school and to support programs that promote parent involvement
3. To advise the school board, principal, and staff on any matter relating to the school, other than matters assigned to the school planning council
4. To assist the principal and staff in ensuring the highest safety standards are maintained in the school and neighbourhood
5. To promote the interests of public education and, in particular, the interests of General Currie Elementary
6. To contribute to a sense of community within the school and between the school, home, and neighbourhood
7. To organize and support activities for students and parents
8. To provide financial support for the goals of the Council, as determined by the membership
9. To advise and participate in the activities of Richmond District Parents' Association and the BC Confederation of Parent Advisory Councils
10. To provide parent education and professional development and a forum for discussion of educational issues
11. To assist parents in obtaining information and communicating with the principal and staff about their child's progress or other concerns

Section III Interpretation of Terms

“BCCPAC” means BC Confederation of Parent Advisory Councils

“District” means School District No. 38

“RDPA” or “Richmond District Parents’ Association” means the parent advisory councils organized according to the School Act and operating as a district parent advisory council in School District No. 38

“PAC” or “parent advisory council” mean the parents organized according to the School Act and operating as a parent advisory council in General Currie Elementary

“Parent” is as defined in the School Act and means

- (a) the guardian of the person of the student or child,
- (b) the person legally entitled to custody of the student or child, or
- (c) the person who usually has the care and control of the student or child

and, for the purposes of these bylaws, means the parent or guardian of a child or children enrolled in School District No. 38

“School” means any public elementary or secondary educational institution as defined in the School Act operating within School District No. 38

Section I Membership

Voting members

1. All parents and guardians of students registered in General Currie Elementary are voting members of the Council.

Non-voting members

2. Administrators and staff (teaching and non-teaching) of General Currie Elementary may be invited to become non-voting members of the Council.
3. Members of the school community who are not parents of students registered in the public school system may be invited to become non-voting members of the Council.
4. At no time will the Council have more non-voting than voting members.

Compliance with bylaws

5. Every member will uphold the constitution and comply with these bylaws.

Section II Meetings of Members

General meetings

1. General meetings will be conducted with fairness to all members.
2. General meetings will be held not less than four times during the school year at the discretion of the executive. One of those meetings will be the annual general meeting to be held in September of each school year.

Conduct

3. At general meetings, members will not discuss individual school personnel, students, parents, or other members of the school community.
4. The Council will refrain from partisan political action or other activities that do not serve the interests of the school or the public school system.

Notice of meetings

5. Members will be given reasonable notice of general meetings.

Section III Proceedings at General Meetings

Quorum

1. A quorum for general meetings will be five voting members (the minimum number of voting members that can reasonably be expected to attend).
2. If at any time during a general meeting a quorum ceases to be present, business then in progress must be suspended until there is a quorum present or until the meeting is adjourned or terminated.
(A QUORUM IS THE MINIMUM NUMBER OF VOTING MEMBERS THAT NEED TO BE PRESENT AT A MEETING TO MAKE DECISIONS. THE REQUIREMENT FOR A QUORUM ENSURES THAT A REPRESENTATIVE NUMBER OF VOTING MEMBERS ARE PRESENT IN THE ROOM WHEN DECISIONS ARE MADE. THE QUORUM CANNOT BE WAIVED OR SUSPENDED. EVEN BY UNANIMOUS CONSENT.)

Voting

3. Except as provided elsewhere in these bylaws, all matters requiring a vote will be decided by a simple majority of the votes cast (50% plus 1).
4. In the case of a tie vote, the chair does not have a second or casting vote and the motion is defeated.
5. Members must vote in person on all matters. Voting by proxy or E-mail will not be permitted.
6. Except as provided elsewhere in these bylaws, voting is by a show of hands or, where requested by two voting members present, by secret ballot.
7. A vote will be taken to destroy the ballots after every election.

Section IV Executive

Role of executive

1. The executive will manage the Council's affairs between general meetings.

Executive defined

2. The executive will include the president, vice-president, secretary, treasurer, immediate past president and such other members of the Council as the membership decides.
(THE COMPOSITION OF YOUR EXECUTIVE SHOULD SUIT YOUR COUNCIL'S NEEDS. AT A MINIMUM, YOU SHOULD FILL THE POSITIONS OF PRESIDENT, VICE-PRESIDENT, SECRETARY AND TREASURER.)

Eligibility

3. Any voting member of the Council is eligible to serve on the executive, except employees or elected officials of School District No. 38 or the Ministry of Education.

(PERCEPTION OF BIAS – COUNCIL NEEDS TO APPEAR TO BE REPRESENTING THE VOICE OF PARENTS AND PROTECTING THE INTEGRITY OF THEIR MEMBERSHIP. MEMBERS WHO ARE SCHOOL BOARD OR MINISTRY OF EDUCATION EMPLOYEES OR ELECTED OFFICIALS MAY BE SEEN AS HAVING A BIAS AND NOT SPEAKING OR ACTING SOLELY ON BEHALF OF PARENTS.)

Election of executive

4. The executive will be elected at each annual general meeting.
5. Elections will be conducted by the chair of the Nominations Committee.

Term of office

6. The executive will hold office for a term of one year beginning immediately following the election.
7. No person may hold the same executive position for more than four years.

Vacancy

8. If an executive member resigns or ceases to hold office for any other reason, the remaining executive members may appoint an eligible member of the Council to fill the vacancy until the next annual general meeting.

Removal of executive

9. The members may, by a majority of not less than 75% of the votes cast, remove an executive member before the expiration of his or her term of office, and may elect an eligible member to complete the term.
10. Written notice specifying the intention to make a motion to remove the executive member must be given to all members not less than 14 days before the meeting.

Remuneration of executive

11. No executive member may be remunerated for serving on the executive, but may be reimbursed for expenses reasonably and necessarily incurred while engaged in the Council's affairs.

Section V Executive Meetings

Meetings

1. Executive meetings will be held at the call of the president every month during the school year. At least one meeting will be held before each general meeting.

Quorum

2. A quorum for executive meetings will be a majority (50% plus 1) of the members of the executive.

Notice

3. Executive members will be given reasonable notice of executive meetings.

Voting

4. All matters requiring a vote at executive meetings will be decided by a simple majority of the votes cast (50% plus 1).
5. In the case of a tie vote, the chair does not have a second or casting vote and the motion is defeated.

Section VI Richmond District Parents Association and Committee Representatives

Richmond District Parents Association representative

1. One representative to the RDPA may be elected annually from among the voting members who are not employees or elected officials of School District No. 38 or the Ministry of Education.

Election of SPC and DPAC representatives

2. The election of representatives to the RDPA must be by secret ballot.

Term of office

3. RDPA representatives will hold office for a term of one year.

Vacancy

4. If the RDPA representative resigns or ceases to hold office for any other reason, the membership may elect an eligible member of the Council to fill the vacancy for the remainder of the term. Such election must be by secret ballot.

Committees Representatives

5. The representative will report to the membership or executive as required.

Section VII Conduct of Executive and Representatives

Code of ethics

1. On election or appointment, every executive member and representative must sign and agree to abide by a code of ethics acceptable to the membership (see Appendix A at the end of these bylaws).

Representing the Council

2. Every executive member and representative must act solely in the interests of the parent membership of the Council.

Privilege

3. Any information received in confidence by an executive member or representative from school personnel, a student, parent, or other member of the school community is privileged and must not be divulged without permission of the person giving the information.

Disclosure of interest

4. An executive member or representative who is interested, either directly or indirectly, in a proposed contract or transaction with the Council must disclose fully and promptly the nature and extent of his or her interest to the membership and executive.
5. Such an executive member or representative must avoid using his or her position on the Council for personal gain.

Section VIII Duties of Executive and Representatives

A. The President will

- (a) speak on behalf of the Council
- (b) consult with Council members
- (c) preside at membership and executive meetings
- (d) ensure that an agenda is prepared and distributed
- (e) appoint committees where authorized by the membership or executive
- (f) ensure that the Council is represented in school and district activities
- (g) ensure that Council activities are aimed at achieving the purposes set out in the constitution
- (h) be a signing officer
- (i) submit an annual report

(THE MEETING AGENDA IS USUALLY THE PRESIDENT'S RESPONSIBILITY. IT IS GOOD PRACTICE TO CONSULT WITH EXECUTIVE, MEMBERSHIP, AND PRINCIPAL BEFORE THE MEETING TO GIVE THEM AN OPPORTUNITY FOR INPUT. THE TERMS "PRESIDENT" AND "CHAIRPERSON" ARE OFTEN USED INTERCHANGEABLY. THE PRESIDENT USUALLY GIVES A REPORT AT EACH MEETING OUTLINING WORK DONE AND ISSUES CONSIDERED SINCE THE LAST MEETING)

B. The Vice-President will

- (a) support the president
- (b) assume the duties of the president in the president's absence or upon request
- (c) assist the president in the performance of his or her duties
- (d) accept extra duties as required
- (e) be a signing officer
- (f) submit an annual report

C. *The Secretary will*

- (a) ensure that members are notified of meetings
- (b) record, distribute and file minutes of all meetings
- (c) keep an accurate copy of the constitution and bylaws, and make copies available to members upon request
- (d) prepare and maintain other documentation as requested by the membership or executive
- (e) issue and receive correspondence on behalf of the Council
- (f) ensure safekeeping of all records of the Council
- (g) submit all minutes, documents, records and correspondence into the PAC binder located in the Principal's office

D. *The Treasurer will*

- (a) be a signing officer
- (b) ensure all funds of the Council are properly accounted for
- (c) disburse funds as authorized by the membership or executive
- (d) ensure that proper financial records and books of account are maintained and kept in the PAC binder located in the Principal's office
- (e) report on all receipts and disbursements at general and executive meetings
- (f) make financial records and books of account available to members upon request
- (g) have the financial records and books of account ready for inspection or audit annually
- (h) with the assistance of the executive, draft an annual budget
- (i) ensure that another signing officer has access to the financial records and books of account in the treasurer's absence
- (j) submit an annual financial statement at the annual general meeting

E. The RDPA Representative will

- (a) attend all meetings of the RDPA and represent, speak, and vote on behalf of the Council
- (b) maintain current registration of the Council
- (c) report regularly to the membership and executive on all matters relating to the RDPA
- (d) seek and give input to the RDPA on behalf of the PAC
- (e) receive, circulate, and post RDPA newsletters, brochures, and announcements
- (f) receive and act on all other communications from the RDPA
- (g) liaise with other parents and RDPA representatives

F. Members-at-Large (Directors) will

- (a) serve in a capacity to be determined by the Council at the time of election, and at other times as the Council requires

G. The immediate Past President will

- (a) advise and support the membership and executive
- (b) provide information about resources, contacts, and other matters
(ANNUAL REPORTS ARE IMPORTANT BECAUSE THEY: (1) PROVIDE AN OPPORTUNITY TO REVIEW PERSONAL AND COUNCIL GOALS AND ACHIEVEMENTS; (2) PROVIDE A RECORD OF ACTIONS TAKEN; AND (3) OUTLINE RESPONSIBILITIES FOR THOSE CONSIDERING RUNNING FOR AN EXECUTIVE POSITION)

Section IX Committees

1. The membership and executive may appoint committees to further the Council's purposes and carry on its affairs.
2. The terms of reference of each committee will be specified by the membership or executive at the time the committee is established, or by the committee at its first meeting, as the membership or executive decide.
3. Committees will report to the membership and executive as required.
4. A Nominating Committee will be appointed annually before the annual general meeting held in September at the start of the new School Term
(A STANDING COMMITTEE EXISTS EVERY YEAR AND MAY BE DESCRIBED IN THE BYLAWS. EXAMPLES ARE VOLUNTEER CO-ORDINATOR, HOT LUNCH, EARLY WARNING, FUNDRAISING AND SPECIAL EVENTS. AN AD HOC COMMITTEE IS CREATED TO DO A SPECIFIC TASK WITHIN A CERTAIN TIME PERIOD.)

Section X Financial Matters

Financial year

1. The financial year of the Council will be September to June.

Power to raise money

2. The Council may raise and spend money to further its purposes.

Bank accounts

3. All funds of the Council must be kept on deposit in the name of the Council in a bank or financial institution registered under the Bank Act.

Signing authority

4. The executive will name the President, Vice-President and Treasurers to be signing officers for banking and legal documents. Two signatures will be required on all of these documents.

Annual budget

5. The executive will prepare a budget and present it to the membership for approval before the current budget expires.

(THE BUDGET GIVES THE EXECUTIVE AUTHORITY TO SPEND MONEY. WITHOUT A CURRENT BUDGET, THE EXECUTIVE CANNOT SPEND MONEY. A BUDGET COVERS A TIME PERIOD WITHIN A COUNCIL'S FINANCIAL YEAR, USUALLY THE ENTIRE FINANCIAL YEAR. IT MUST NOT EXTEND OVER MORE THAN ONE FINANCIAL YEAR.)

Non-budgeted expenditures

6. The executive will present all proposed expenditures beyond the current budget for approval at the next general meeting.

Treasurer's report

7. A treasurer's report will be presented at each general meeting.

Auditor

8. Members at a general meeting may appoint an auditor.

Section XI Constitution and Bylaw Amendments

1. The members may, by a majority of not less than 75% of the votes cast, amend the Council's constitution and bylaws.
2. Written notice specifying the proposed amendments must be given to the members not less than 14 days before the meeting.
3. Where the proposed amendments exceed one page, they need not be given to every member, but must be posted in a conspicuous place in the school or made accessible to all members.

Section XII Property in Documents

1. All documents, records, minutes, correspondence, or other papers kept by a member, executive member, representative, or committee member in connection with the Council shall be deemed to be property of the Council and shall be turned over to the president when the member, executive member, representative, or committee member ceases to perform the task to which the papers relate.

Section XIII Dissolution

1. In the event of winding up or dissolution of the Council, and after payment of all debts and costs of winding up or dissolution, the assets and remaining funds of the Council shall be distributed to another parent advisory council or councils in School District No. 38 having purposes similar to those of the Council, as the members of the Council may determine at the time of winding up or dissolution.
2. In the event of winding up or dissolution, all records of the Council shall be given to the principal of General Currie Elementary.

Appendix A Code of Ethics

A parent who accepts a position as a Council executive member, representative or committee member:

1. upholds the constitution and bylaws, policies, and procedures of the electing body
2. performs his or her duties with honesty and integrity and in the interests of the Council
3. works to ensure that the well-being of students is the primary focus of all decisions
4. respects the rights of all individuals
5. takes direction from the membership and executive
6. encourages and supports parents and students with individual concerns to act on their own behalf, and provides information on the process for taking concerns forward
7. works to ensure that issues are resolved through due process
8. strives to be informed and only passes on information that is reliable
9. respects all confidential information
10. supports public education
